## Statutory Holidays

#### Legislation governing Statutory Holidays

Statutory Holidays are governed by Article 37 of the Law on the Statute of Workers (<u>Real Decreto Legislativo 2/2015</u>, <u>de 23 de octubre</u>, <u>por el que se aprueba el texto refundido de la Ley del Estatuto de los Trabajadores</u>). Employees are entitled to 14 employer-paid statutory holidays, which include four regional and two municipal holidays.

The dates of employer-paid statutory holidays that employers must observe for 2024 in Spain's 17 autonomous communities and the cities of Ceuta and Melilla have been set by the Resolution of 23 October 2023, issued by the General Directorate of Labor, which provides the list of 2024 statutory holidays (*Resolución de 23 de octubre de 2023, de la Dirección General de Trabajo, por la que se publica la relación de fiestas laborales para el año 2024*). The Resolution was published in the Official Journal (*Boletín Oficial del Estado*) on 27 October 2024.

#### Schedule of 2024 Statutory Holidays

As indicated above, employees are entitled to 14 statutory holidays, which include four regional and two municipal holidays. In 2024, statutory holidays are as indicated in the table below.

#### Pay in Lieu provisions

The Law on the Statute of Workers is silent with respect to payments in lieu of observance of statutory holidays.

#### Working on a Statutory Holiday

The Law on the Statute of Workers is silent regarding work performed on a statutory holiday.

#### Holidays that fall on a non-working day

A government Resolution setting the dates of statutory holidays typically moves the observance of holidays that fall on a non-working day to allow for a day off from work. This substitution is provided for by Article 37.2 of the Law on the Statute of Workers.

#### Bridging of holidays

A government Resolution setting the dates of statutory holidays typically moves the observance of holidays that fall mid-week or on a non-working day to the following Monday.
